1. Applicants must apply online on website: www.cup.edu.in; www.cup.ac.in only.
2. Printed copy of the online application needs to be submitted at the time of document verification, interaction/interview, date of which will be notified on later stage on website only. Candidates are advised to remain updated with university websites mentioned above.
3. The university reserves the right to withdraw the post at any time without assigning any reason.
4. The right is also reserved with the university either to fill or not to fill the post. The decision in this regard shall be final by the Competent Authority of the university.
5. Application fee for the post is Rs. 100/- which is to be paid online. The SC/ST/PWD candidates are exempted from application fee.
6. Application fees once paid shall not be refunded under any circumstances. Before applying for the post, candidates are advised to satisfy themselves about their eligibility.
7. The candidates having experience of working in Central/State Government universities will be preferred.
8. Canvassing in any form may lead to cancellation of candidature.
9. **Incomplete applications** or without relevant supporting enclosures (self-attested copies of degree/certificates /marks sheets/experience certificate, etc.) **will be out-rightly rejected.**
