1. **Applicants must apply on prescribed form available on website: www.cup.edu.in; www.cup.ac.in.** Applications received in any other form than prescribed form will be rejected.
2. The university reserves the right to withdraw any advertised post at any time without assigning any reason.
3. The right is also reserved with the university either to fill or not to fill the post. The decision in this regard shall be final by the Competent Authority of the university.
4. In case the number of candidates exceeds 20, the university may conduct written test for shortlisting.
5. Application should be accompanied with a non-refundable **demand draft of Rs.100/-** drawn in favour of the **Central University of Punjab** payable at **Bathinda**.
6. The SC/ST/PWD candidates are exempted from application fee.
7. Application fees once paid shall not be refunded under any circumstances. Before applying for the post, candidates are advised to satisfy themselves about their eligibility.
8. The candidates having experience of working in Central/State Government universities will be preferred
9. Number of posts advertised may be treated as tentative. The University shall have the right to increase/decrease the number of posts.
10. The candidates are required to bring the Application form & Hall Ticket duly filled by the candidate, while reporting for the Written test/Interview.
11. University will not be liable to wait in case the applicant does not bring the filled application form with supporting documents will not be allowed to sit in the examination.
