On the basis of Interview held 10th and 11th December 2019 for admission to Ph.D. Programme for Academic Session 2019-20 Starting from January-2020 (For JRF, NET, GATE, GPAT, DBT-BET & JEST (Physics)) in Central University of Punjab, the list of candidates, selected for provisional admission are as below:

Candidate must have qualified UGC/CSIR/ASRB-NET, ICMR-JRF, GATE, GPAT, DBT-BET & JEST (Physics) with existing validity and must have some financial assistance such as UGC/CSIR/ICMR/DBT-JRF, financial assistance from Govt. agencies {Like Rajiv Gandhi National Fellowship (RGNF), Maulana Azad National Fellowship (MANF) etc.} / Industrial Fellowship or working in CUPB projects.
 - (iv) For admission in the Ph.D. Programme candidate must fulfill the eligibility criteria on the date of verification of Documents/Registrations.
