- 6. Aadhaar Card (Original and two self attested Photocopies)
- 7. Caste Certificate (both for SC and OBC candidates) (Original and two self attested Photocopies)
- 8. Latest Income Certificate** (both for SC and OBC candidates)(Original and two self attested Photocopies)

9. Duly filled, signed and stamped Affidavit on Fifty Rupees Non-Judicial Stamp Paper with notary in the prescribed format sent to the selected candidates through email.

**Income declaration of self-employed parents/guardians should be in the form of a certificate issued by a Revenue Officer not below the rank of Tehsildar. Employed parents/guardians are required to obtain an income certificate from their employer and submit a consolidated certificate from the Revenue Officer including any other additional source of income.
