- d) to jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty and members to participate therein

e) to jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty and members to participate therein

Dr. Ambedkar Chair on Human Rights and Environmental Values, Central University of Punjab, Ghudda, Bathinda, Punjab & Environment and Social Welfare Society, Khajuraho, India further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation, etc. Also, the terms and conditions for each program and participation will be worked out by mutual agreement between the two parties.


