Sealed offline tenders are invited from the authorised Recyclers / Re-processors of E-waste registered with Central Pollution Control Board / State Pollution Control Board for auction of obsolete **Desktops, Monitors, Keyboards, Mouse, UPS, Batteries, Printers, Xerox Machines, Telephones sets and other non-serviceable material** on "As is where is basis" and as per extant guidelines of CPCB/ SPCB/ PCC Guidelines for disposing off Recycling/ re-processing of electronics waste.

Eligibility Criteria:

1. Valid Registration for Recycler/Re-processor of E-waste with Competent Authority /Central Pollution Control Board/ State Pollution Control Board in terms of Ministry of Environment & Forest notification number S.O. 1035(E) Dated 12th May 2011. A copy of the certificate must be attached with the bid.
2. Copy of PAN CARD.
3. Copy of GST Certificate and GSTIN be provided.


General Terms & Conditions:-

1. The bids will be valid for a period of 90 days from the date of opening of the bids.
2. The bidders may inspect the items on above scheduled date and time.
3. The items would be sold to the highest bidder.
4. The successful bidder has to make full payment through RTGS/NEFT to the University bank account No. 50100058592507 (IFSC - HDFC000187) Or through Demand Draft in favour of "Central University of Punjab" payable at Bathinda, within 5 (Five) days after confirmation, failing which the offer will be cancelled.

5. The successful bidder shall be required to lift all the items from the disposal site to its premises within 5 (Five) days after the payment of the quoted amount. On failure to do so, Central University of Punjab, Ghudda shall have the right to forfeit the entire amount of the bidder and dispose the items to alternate bidder.
6. Items, once disposed to the successful bidder, shall not be taken back on any condition whatsoever.
7. The total price should be inclusive of all Misc. charges like Transportation, Labour, Loading/Unloading/ GST or any other expenses etc. as all above items are interlinked to each other therefore no comparison will be made on individual item. The contract will be awarded on comparison of consolidated price of all items.
8. The University shall charge GST @18% over & above the quoted rate.

Terms & Conditions for Tender Quoted:-

1. Quotation in sealed envelope should reach to "**The Finance Officer, Central University of Punjab**" VPO-Ghudda -151401 on or before 01:00 PM on 23.06.2021. The quotation must be submitted by or before the due date and time. Bids received after due date and stipulated date and time due to any reason whatsoever, including postal delays shall not be considered.
2. The financial bid should be quoted both in figures and words, along with GST, if any, which shall be borne by the bidder. Any overwriting or erasing the figures shall not be considered for acceptance of the rates offered by the bidder.
3. Central University of Punjab, reserves the right to accept or reject any/ all bids without assigning any reason whatsoever.
4. Each page of the bid documents should be signed by the bidder(s). Incomplete and unsigned bids are liable to be rejected.
5. A declaration in lieu of Earnest Money Deposit (EMD) shall have to be provided as per **Annexure- C** attached, without which the bid shall be summarily rejected.
6. For financial evaluation, the highest bidder shall be chosen based on the figures quoted in **Annexure-A**.
7. Valid authorization/registration certificate issued by competent authority/concerned Centre/State Pollution Control Board for Recycler / Re-processor of E-waste is must to submit with bid as supportive document.
