- 3. It is suggested to include 'Econometrics book by Johnston & Donald' in the reacting list of the course ECO.551.
- 4. It is suggested to include 'Economics Transformation of a Developing Economy' & 'Agrarian Distress & Farmers' Suicides in North India' in the reading list of the course ECO.554.
- 5. It is suggested to include 'Handbook of Agricultural Economics' in the reading list of the course ECO.703.
- 6. It is resolved that the suggestions made for the revision of the course contents of various courses of M.A. (Sociology) & Ph.D. course work in Sociology by Board Studies are alright, and their incorporations are duly accepted by the School Board.
