Minutes of the 14th Meeting of University Court

The 14th meeting of the University Court of the Central University of Punjab was held on 26th December, 2025 at 11:30 AM in Conference Hall of the Aryabhata Academic Block, Central University of Punjab. The meeting was chaired by Prof. Jagbir Singh, Hon'ble Chancellor of the University.
