1. **Applicants are required to apply online (through recruitment portal: <https://cupnt.samarth.edu.in/>). The application fee of Rs. 100/- (for candidates other than SC/ST/PWD/Women) should be deposited while filling the online application form.**
2. The interview will be conducted at Central University of Punjab, Badal-Bathinda road, V.P.O.- Ghudda, District-Bathinda.
3. Any type of corrigendum/addendum/amendments/notice/updation etc. related to this advertisement shall be uploaded on University websites [www.cup.edu.in](http://www.cup.edu.in) only. Further, the university will not send any further information/call letters by post/newspapers. CUPB will not be responsible for invalid/wrong email ID and Mobile No. mentioned by the candidates. 4. The reservations/relaxations to SC/ST/OBC-NCL/PWD/EWS candidates will be provided as per the existing Govt. of India/UGC rules. OBC certificate (Non Creamy Layer) and EWS certificate should be issued on or after 01.04.2024.
