Mr. Kanwal Pal Singh Mundra, Registrar (presently under suspension) of the University has joined to the post of Registrar on 13.01.2020 (F/N).

2. Clause No. 01 of his offer of appointment vide Ref. No. CUPB/CC/Estt./20/Aptt./PF/1975 dated 13.01.2020 states that "Nature of appointment: Appointment is on tenure basis for a period of five years and eligible for re-appointment, upto attaining the age of 62 years, whichever is earlier, as per Statutes 6(2) of the Central University of Punjab, Bathinda".

3. As per record, his date of birth is 09.08.1961. Accordingly, he is attaining the age of 62 years on 08.08.2023.

4. The University has inadvertently written the date of completion of his tenure/re-employment or date of retirement/superannuation as 31.08.2023 in place of 08.08.2023 in various communications e.g. on Re-fixation of Pay Order dated 24.02.2023, Extension of Suspension Order dated 05.04.2023, Salary Certificate dated 01.09.2021, etc.

5. In view of the above, the date of completion of tenure/re-employment or date of retirement/superannuation as 31.08.2023 be ignored. Further, henceforth, the date of completion of tenure on attaining the age of 62 years in respect of Mr. Kanwal Pal Singh Mundra, Registrar (presently under suspension w.e.f. 12.04.2022) of the University, to be read as **08.08.2023** for all purposes.
