Minutes of 74th Meeting of the Executive Council

74th Meeting of the Executive Council of the Central University of Punjab was held on 15th July 2026 at 11:30 AM in Hybrid mode.

Item.No:EC:74:2026:SA:2 To consider the representation of Prof. Zameerpal Kaur Sandhu Bajw, Department of Punjabi on the guidelines in matter relating to appointment of HoD's and Deans of Schools.	<u>AGENDA NOTE:</u> The Executive Council in its 72nd meeting vide item No. EC: 72:2026:SA:8(i) held on 12.06.2026 unanimously approved the recommendations of Committee constituted to frame guidelines for appointment of Heads of Departments (HoDs) and Deans of Schools and also resolved to approve the guidelines in the matter. Accordingly, the guidelines relating to appointment of HOD's and Deans of School were circulated vide Notification No. CUPB/Estt./Notification/2026/58 dated 02.07.2026. Now, Prof. Zameerpal Kaur Sandhu Bajwa, Department of Punjabi vide letter dated 14.07.2026 submitted the representation against the said guidelines. Prof. Bajwa vide her said email has requested to withdraw the circulated guidelines and further requested to appoint her as Dean, School of Language, Literature and Culture. The matter is placed before the Council for consideration.
<u>RESOLVE</u>	The Council, considered the representation submitted by Prof. Zameerpal Kaur Sandhu Bajwa, Department of Punjabi and after detailed deliberations, unanimously resolved that the guidelines governing the appointment of HoDs and Deans have been framed strictly in accordance with the Act, Statutes, and Ordinances of the University. Following comprehensive deliberations, these guidelines were duly considered and approved by the Executive Council in its 72nd Meeting. Accordingly, the Council found that the representation submitted by Prof. Zameerpal Kaur Sandhu Bajwa does not hold merit and, therefore, unanimously resolved not to accede to the same. The Council further unanimously resolved that, a reasoned reply to the representation, strictly in accordance with the provisions of the Act, Statutes, Ordinances, and the said approved guidelines be conveyed to Prof. Bajwa. The Council also unanimously resolved that the aforesaid guidelines will continue to remain in force. <i>Note: Prof. Alpna Saini, who was also attending the EC meeting as a member, recused herself during the discussion of this agenda item due to conflict of interest. She rejoined the meeting after deliberations on the said agenda item were concluded.</i>
