Minutes of the 11th Meeting of the University Court

The 11th meeting of the University Court of the Central University of Punjab was held on 21st November, 2022 at 03:00 PM in Conference Hall of the Aryabhatta Academic Block, Permanent Campus, Central University of Punjab, VPO Ghudda. The meeting was chaired by the Hon'ble Chancellor CUPB, Prof. Jagbir Singh.

The Vice Chancellor, CU Punjab extended a warm welcome to Chairman of the University Court & Chancellor, Central University of Punjab, other members present and thanked them for sparing their precious time for contributing towards the academic and administrative growth of the University and for their valuable guidance. The Vice Chancellor gave an account of the academic & infrastructure development that took place in the previous year.
