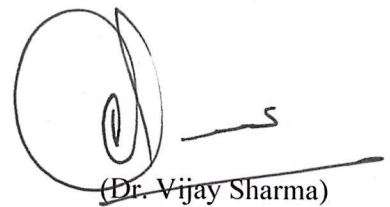
NOTIFICATION
